1. **That Asar Bai Charitable Society** H. No. 566 Sector-14, Gurgaon is a registered Society under the Haryana Registration And Regulation of Societies Act 20 2 (Haryana Act No.1 of 2012)

2. That Asar Bai Charitable Society H. No. 566 Sector-14, Gurgaon That the school is being run as a community service and not as a business and that commercialization does not take place In the school in any manner whatsoever.

The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.
- 7. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.
- 8. That the school will ensure that the Building Safety, fire Safety, water Safety, Health and hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
- 9. That the school will ensure that all required infrastructure is available with the school before starting classes.
